The Washboard Arts & Music Festival and Board are nonpartisan, and no preference will be given to any political party or candidate.

Application and payment deadline: May 15, 2024.

No application will be accepted without payment.

Vendor Guidelines

- Political Booths must have someone working their booth during all vendor hours.
- Security is provided by the Logan Police Department from Thursday morning through Saturday night.

Setup

- 8:00 a.m. to 4:00 p.m. on Thursday, June 13.
- All booths must be ready for the public on June 13^h by 4:00 p.m.

Tear-Down

- Vendors may start to pack up after 9:00 p.m. closing on Saturday night.
- NO vehicles will be permitted on the streets near the main stage until the music stage closes at 11:00 p.m. This will be strictly enforced.

Vendor Parking

Vehicles and supply trailers must be removed from your space during fest hours.

If you have a large truck and/or cargo trailer combination, please contact us prior to the festival to arrange a specific time for setup, and trailer parking arrangements.

POLITICAL VENDOR INFORMATION AND APPLICATION – 2024

The following activities are NOT permitted:

- Food or drink sales
- Lottery, scratch-off tickets or raffles
- Microwaves or air conditioners
- Sexually explicit or vulgar items
- Flea market items, plastic toys, trinkets, prank items, junk jewelry, fake cigarettes or any other items deemed inappropriate by the Festival Committee
- Music without written permission of the Fest Committee
- Dangerous animals including non-controlled, non-leashed or barking dogs.
- Tent stakes to secure tents. The festival is held on city streets.
- Loud or excessive noise
- Soliciting outside of your booth or rental space
- Any political sign, banner, advertisement, clothing (including clothing worn by vendor staff), or other items displayed in your booth that are deemed to be vulgar or offensive by any member of the Washboard staff must be immediately removed and may not return to your booth. Failure to adhere to this provision may result in the closure of your booth, and a permanent ban from exhibiting at the Washboard Arts and Music Festival in the Future.
- No negative campaign materials or derogatory statements about an opposing campaign or candidate will be permitted. Please restrict your materials to promoting your candidate(s) and their qualifications.

Electrical Requirements—Electricity is available at a limited number of spaces:

- 1 fan per 10 x 10 space
- You must supply a minimum 10-gauge wire 3-prong (at least 100 ft.) extension cord.
- Maximum of 2 fluorescent light bulbs per 10 x 10 space.
- Fluorescent or LED lights only! No halogen bulbs allowed.

The Festival electrician and/or Festival representative may ask you to unplug certain items, if necessary, to lower power consumption.

**This contract is not transferable. If you would like to participate in the 2024 Washboard Festival, you will be required to resubmit a new application.

Hocking County Tax Rate for 2024 is 7.25%. (Tax is not required in payment for space at the Fest.)
